Schindler can compare with the best of them for hard running, but he seldom has had the opportunity to help pave the way. Then too, there is a difference in playing close to the line and in the safety position. Notre Dame contest is still some time away, and Schindler handles his new assignment better every day. Besides, Banta and Sangster aren't definitely out of the Irish tilt as yet.

This happened in an all-U handball match between Al Mahaffay and Fred Nicholas. The latter won the first game 21-13, with Mahaffay winning the second, 21-14. Nicholas suffered from chills, so he was given a rub-down between the sevond and third games. The rules say that only 10 minutes are allowed between games, so Nicholas returned to the court when he figured time was up. Mahaffay said nothing, and Nicholas went on to win 21-18. Of course his opponent congratulated him, and this victory put Nicholas in the semi-finals.

The following day, Nicholas received word that his semi-final match could not be played until he had seen Andy Anderson, who is in charge of all such tournaments.
